## **VIEW ON MARKET PERFORMANCE**

## Smaller Stocks Shine - as expected!

Indian markets rallied strongly today, driven by robust performance in banking and metal stocks. Kotak Mahindra Bank's impressive earnings results propelled the Nifty Bank index up by 810 points (1.67%). The index faced resistance at its previous swing high of 23,391, leading to modest profit-taking near the session's close. Trading volumes in the cash market increased by 6% compared to the previous day.

The market's upward momentum was further supported by gains in Wipro and positive global sentiment. As we anticipated in our opening bell commentary - broader markets showed strength, Mid and small-cap segments continued their winning streak for the fifth consecutive session, outperforming the benchmark Nifty index. The Nifty Midcap 100 advanced by 0.91%, while the Nifty Smallcap 100 surged over 1%. Market breadth remained positive, with the BSE's advance-decline ratio at 1.61.

Among sectoral indices, PSU Banks, Private Banks, Metals, and Media emerged as the top performers, while Auto and FMCG sectors closed in negative territory.

If the Nifty sustains above 23,391, it could establish a higher top, following the higher low at 23,100. This pattern potentially signals a shift from bearish to bullish momentum. Traders maintaining long positions are advised to set stop-losses at 23,100. The 23,600-23,700 range appears to be the next significant resistance level.

Looking ahead, U.S. markets will be closed today for Martin Luther King Jr. Day, coinciding with Donald Trump's presidential inauguration ceremony. With limited global cues expected, Indian markets are likely to continue trading in line with today's momentum.
