VIEW ON MARKET PERFORMANCE

Nifty rose for the third consecutive session to close at yet another new all time high. At close, Nifty was up 0.62% or 147.5 points at 23868.80. Cash market volumes on the NSE were higher by 10% as compared to yesterday.

Broader market Indices remained in the narrow range where Nifty Small cap 100 Index gained 0.25% while Nifty midcap 100 Index ended marginally in the red. Declining shares marginally outnumbered the advancing shares as advance decline ratio stood at 0.97 levels on BSE

Among sectors, Nifty Media, OIL/GAS and Privative Banks gained the most while Metal, Reality and Auto fell the most.

Trend of the Nifty remains positive. A level of 23660 has become new support for the Nifty and with that stop loss trading long positions should be held.

On the higher side, next resistance is seen at 24125, which happens to be 138.2% Fibonacci retracement of the entire fall seen from 23338(3rd June Top) to 22281(4th Jun Bottom).
