VIEW ON MARKET PERFORMANCE

Nifty ended at record high on June 27 and crossed another milestone by scaling past the 24,000 mark. At close, Nifty was up 0.74% or 175.7 points at 24044.5. Cash market volumes on the NSE were higher at Rs.1.76 lakh cr. Broad markets underperformed the Nifty even as the advance decline ratio fell sharply to 0.48:1.

Shares fell Thursday in most Asian markets ahead of a key U.S. inflation report due Friday that might point the way ahead for interest rates. European shares were however muted/mildly higher.

Nifty rose for the 4th consecutive session on June 27 and validated the bullish 3 advancing soldiers pattern formed on the previous day. Nifty also registered a smart 6.9% gain in the Monthly F&O series that expired on June 27. Nifty could now rise towards 24125 resistances while 23754 could offer support in the near term.
